



S-1 .22 SHORT (HIGH VELOCITY). "MASTERCRAFT SUPREME". Gold, white and black box with red, white and black printing. One-piece box with end flaps. Part No. SB1450 on sides. "CC-1" h/s on a brass case. Copper washed bullet. Produced by Cascade Cartridge Co.

LR-1 .22 LONG RIFLE (HIGH VELOCITY). "MASTERCRAFT SUPREME". Gold, white and black box with red, white and black printing. One-piece box with end flaps. Part No. SB1460 on side. 'CC-1' h/s on a brass case. Copper washed bullet. Produced by The Cascade Cartridge Co.
(a) "C-8" h/s used in 1964 issues. Ref Chris Ueberroth



LR-1.1 .22 LONG RIFLE (HIGH VELOCITY). "MASTERCRAFT SUPREME". Same as LR-1 except the "TO" in the logo does not have the white USA background.

LR-1.2 .22 LONG RIFLE (HIGH VELOCITY). "MASTERCRAFT SUPREME". Same as LR-2 except the red ink registration is off to the left.





- (a) "A" sides. "B" Bottom
 - (b) "B" sides.. "A" Bottom.
 - (c) Front is "B" side. Back is "A" side. "A" bottom.



- LR-2 **.22 LONG RIFLE (HIGH VELOCITY), "MASTERCRAFT".** Bright gold and black box with red and black printing. One-piece box with end flaps. Product code SB 0960-2 on sides. "D-5" h/s on a brass case. Copper washed bullet. Produced by C.I.L. in Canada. Variations noted:
- (a) Bright gold box.
 - (aa) "B" Bottom.. "A" sides Front and Back.
 - (ab) "A" Bottom. "B" sides Front and back.
 - (ac) "A" Bottom. "B" side front, "A" side back.
 - (b) Dull gold box. "B" bottom. "A" side front and back.





LR-1 .22 LONG RIFLE (HIGH VELOCITY). "MASTER MAG". Box of 50. Clear box with a clear lid. Gold and blue label with white and black printing. Wrap around side label covers both ends and one side. Other side is clear plastic.. Part No. 606-0073 on ends. "D-5" h/s on a brass case. Lead bullet. Produced in Canada by C.I.L. registration logo after MASTER-MAG



LR-1.1 .22 LONG RIFLE (HIGH VELOCITY). "MASTER MAG". Same as LR-1 but no registration logo after MASTER-MAG . Wrap around side label only covers one end and one side. Other side and end are clear plastic.



LR-2 .22 LONG RIFLE (HIGH VELOCITY). "MASTER MAG". Box of 100. Red box with a clear lid. White and blue label with gold and blue printing. Part No. 608-0014 on end. Copper washed bullet. Produced by Winchester. *End label from the Dean Grua collection.*



LR-3 .22 LONG RIFLE (HIGH VELOCITY). "MASTER MAG". Box of 100. Red box with a clear lid. White label with yellow and black printing. Part No. 608-0014 on bottom. "H-11" h/s on a brass case. Copper washed bullet. Made by Winchester.
