

# SMITH & WESSON

This manufacturer first starting to produce their first "First Model-First Issue Revolver" in 1857. They also probably started to produce cartridges at the same time. In 1863, SMITH, HALL & FARMER took over the ammunition production from SMITH & WESSON.

- S-1 **.22 SHORT**. "No. 1 PISTOL CARTRIDGES". Box of 100. Black label with gold printing. Orange and black mottled box. Two-piece, half-split box. White side sealing label on the ends only. The ends have the SMITH & WESSON name in script format. No h/s on a copper case. Lead cast bullet. This probably is the first box produced and was produced at the same time as the First Model-First Issue Revolver.
  
- S-1.5 **.22 SHORT**. "No. 1 PISTOL CARTRIDGES". Similar to S-1 box but different fonts.
  
- S-2 **.22 SHORT**. "100 No. 1 PISTOL CARTRIDGES" Black label with gold printing. Orange and black mottled box. Two-piece, half-split box. No h/s on a copper case. Lead cast bullet. This box shows the First Model-Second Issue Revolver on top and was probably produced in the early 1860' s.
  
- S-3 **.22 SHORT**. "100 No. 1 PISTOL CARTRIDGES". This label reads . MANUFACTURED FOR SMITH & WESSON REVOLVERS". Who produced this box is not known. It should have been produced in the same time span as the above labels, but probably not by SMITH & WESSON

# SMITH & WESSON

Approximately 1974, SMITH & WESSON thru their S&W AMMUNITION CO. of Alton, Ill. contracted with CARTUCHOS DEPORTIVOS de MEXICO, S.A. to produce a private label box to be sold under the SMITH & WESSON name. This program was discontinued approximately 1979.

S-1 **.22 SHORT (BLANK).** "FOR INDOOR USE". Box of 100. White box with blue printing. One-piece box with top flaps. No tray. Bulk packed. "A-9" h/s on a brass case. The bases can be painted gray, brown, green or yellow. Rose crimped. These were produced by ALCAN.



S-2 **.22 SHORT (BLANK).** "FOR OUTDOOR USE". Blue box with white printing. One-piece box with top flaps. No tray. Bulk packed. "A-9" h/s on a brass case. The bases can be painted gray, brown, green or yellow. Rose crimped. These were produced by ALCAN.



S-3 **.22 SHORT. (HIGH VELOCITY).** "MAX-VELOCITY". Blue box with white printing. One-piece box with end flaps. No product code on the box. "S-1" h/s on a nickel washed brass case. Lead bullet.



LR-1 **.22·LONG RIFLE (HIGH VELOCITY).** "MAX-VELOCITY". Blue box with white printing. One-piece box with end flaps. No product code on the box. "S-1" h/s on a nickel washed brass case ~ Lead bullet.


